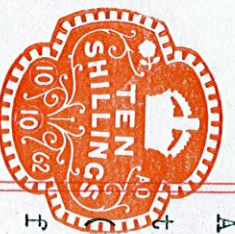

BETWEEN THE COUNTY COUNCIL OF THE ADMINISTRATIVE COUNTY OF DEVON (hereinafter referred to as "the County Council") of the one part and THE PARISH COUNCIL OF MORETONHAMSTEAD (hereinafter referred to as "the Parish Council") of the other part

WHEREAS :-

(1) The County Council is the library authority under the Public Libraries Acts 1892 to 1919 (hereinafter referred to as "the said Acts") for the area of the Newton Abbot Rural District other than the Parish of Moretonhampstead



(2) The Parish Council is the library authority under the said Acts for the library area comprising the said Parish

(3) In pursuance of the powers contained in section 2(1) of the Public Libraries Act 1919 the County Council and the Parish Council have agreed that the Parish Council shall relinquish their powers and duties under the said Acts in favour of the County Council

NOW THIS DEED WITNESSETH that as from the date of this Agreement:-

1. The Parish Council shall relinquish in favour of the County Council their powers and duties under the said Acts and the said powers and duties shall cease and the provisions of the said Acts shall have effect as if the County Council had passed a resolution adopting the said Acts as respects the said Parish
2. Residents of the said Parish shall be entitled to utilise the facilities afforded by the county library to be maintained by the County Council at Moretonhampstead free of charge but subject to the Rules and Regulations made from time to time in respect of such library by the County Council
3. All property and rights acquired or vested in the Parish Council for the purpose of the performance of their powers and duties as a library authority shall be transferred to and be vested in the County Council and any liabilities incurred for that purpose shall be liabilities of the County Council
4. The County Council shall levy in the said Parish a precept for the county library rate
